# YOUR 2018 PROPERTY TAX BILL

The tax rate for City purposes is \$6.39 per thousand of assessed valuation. This represents an increase of 1 cent per thousand for City purposes. Below is a comparison of assessed tax rates for 2017 and 2018 by the different taxing jurisdictions.

## HARTFORD SCHOOL DISTRICT

For those electors living in the Hartford School District, the net tax rate for 2018 is \$17.61 per thousand of assessed valuation which is a 43 cent decrease over last year's tax bill.

Overpayments will be issued a refund check within 15 working days of receipt of payment.

## DOG AND CAT LICENSES

**APRIL 1, 2018 is the last day to pay dog licenses and cat licenses without penalty.**

Unneutered Male or Unspayed Female \$20.00

Neutered Male or Spayed Female \$10.00

After April 1, 2018, a \$5.00 late fee will be added to the above fees. A current rabies immunization statement from a veterinarian must be submitted with the application. Applications are available online at [www.ci.hartford.wi.us](http://www.ci.hartford.wi.us)
