Notification of Plumber Inspector for inspection and test is required within 10 days.

All plumbing work must be left open until such time the inspector has completed his examination and inspection. 1 1/2" and 2" meter and flanges supplied by water department. Plumber must pick up meter and connections at water department. Meter Yokes must be used for 5/8" to 1" meter.

For New Construction: Before final inspection, water meter must be installed.
