## 4.) ANTICIPATED PROJECTS/TASKS/ACTIVITIES

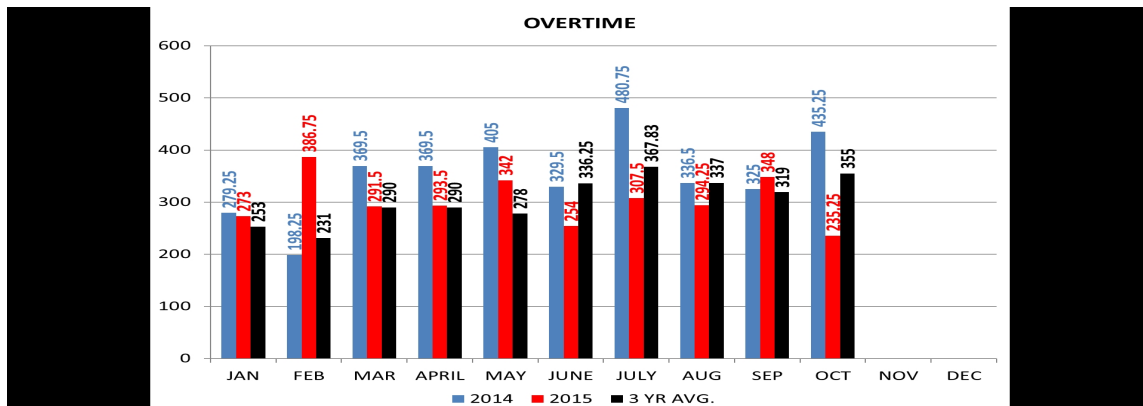
- ◆ Current Emergency Communications Center vacancy will be filled

**7.) CASES OF INTEREST**

- ◆ 10-25-15 – Hartford officers performed a traffic stop on a vehicle after the officer witnessed a passenger throwing an object out the window at a subject at the skate park. The K-9 and his partner were requested, and the K-9 did alert on the vehicle. Several items of paraphernalia and a large hunting knife, approximately 7-8 inches long, were located inside the vehicle. Citations for carrying a concealed weapon, disorderly conduct, and possession of drug paraphernalia were issued to a 17-year-old Hartford man. A second citation for possession of drug paraphernalia was also issued to a 16-year-old juvenile for their involvement in this incident.
