Important Tax Information

Enclosed is your 2023 Property Tax Bill. Bills are now being mailed by property address not owner's name. Please note this change if you have multiple tax bills for various addresses in your name.

Tax Payment Receipts Will No Longer Be Mailed Out

To obtain a paid receipt, check the payment status, or acquire additional copies of your tax bill, please log onto the Washington County website at: www.washcowisco.gov and click on "Taxes/Assessment Information" located within the scrolling menu.

If you require or still wish to receive a mailed receipt, please enclose a self-addressed stamped envelope with your payment.

TAX PAYMENT OPTIONS

Tax payment options include in-person, online, mail, or our two drop box locations in front and back of City Hall open 24 hours a day.

REMINDER: When mailing Tax Payment **ENCLOSE A TAX STUB** with your remittance to **109 North Main Street, Hartford, WI 53027**. Anyone planning to apply for State Property Tax Relief must have a Tax Receipt.

OVERPAYMENTS: Overpayments will be issued a refund check within 15 working days of receipt of payment.

DEBIT/CREDIT: If paying by debit/credit card please refer to the enclosed brochure from PSN. The PSN link is now open and will close on January 31st, 2023 at midnight.

* DO NOT use Washington County's point and pay system to make your payment.

You may elect to utilize the real estate tax installment plan by paying your taxes according to the following schedule:

1st Installment -- January 31, 2023

If the installment plan is not utilized, full payment is due to the City of Hartford by January 31, 2023.

Assessments and Personal Property taxes may not be paid in installments, they must be paid in full by January 31, 2023.

TAX PAYMENTS POSTMARKED 2022, BUT DELIVERED IN 2023, WILL BE RECEIPTED AS 2023 BUT NOTED AS PAID IN 2022.

DOG AND CAT LICENSES

APRIL 1, 2023 is the last day to pay dog licenses and cat licenses without penalty. After April 1, 2023, a \$5.00 late fee will be added to the below fees.

Unneutered Male or Unspayed Female \$20.00

Neutered Male or Spayed Female \$10.00

License and proof of vaccination will be returned to you via mail. *License will not be processed without current rabies vaccination information from a veterinarian.*

Important Tax Information

YOUR 2023 PROPERTY TAX BILL

The tax rate for City purposes is \$4.67 per thousand of assessed valuation. Below is a comparison of assessed tax rates for 2022 and 2023 by the different taxing jurisdictions.

Hartford School District

For those electors living in the Hartford School District, the net tax rate for 2023 is \$12.41 per thousand of assessed valuation which is a \$4.08 decrease over last year's tax bill.

For those electors living in the Slinger School District, the net tax rate for 2023 is \$12.02 per thousand of assessed valuation which is a \$3.47 decrease over last year's tax bill.
